7. Old Business

7.1 As stated in the February 2013 Minutes: "In ANC 2D there are 6 establishments which hold **ABC licenses**. Of these 6, 5 of the licenses are up for renewal this year (4 in March and 1 in September). Of the 6 establishments only one (Russia House) has a volunteer agreement (now called a Settlement Agreement) which is also up for renewal. Residents should look for Placards which will be posted at each location announcing the renewal process. The 6 establishments are: 1)Open Door Market (Class B; not up for renewal this year); 2)Pines of Florence (*Class C); 3) Washington Courtyard by Marriott (*Class C); 4) The Churchill Hotel (*Class C); 5) Russia House (*Class C); and 6) Veritas Wine Bar (Class D; renewal in September 2013). *Renewal March 2013". Placards have been posted in 3 establishments:1) Pines of Florence, SMD01 and 2) The Churchill Hotel, SMD02...both have petition date of 5/20/13 and hearing date of 6/3/13; and 3) Russia House, SMD02...petition date of 5/28/13 and hearing date of 6/10/13. This is our opportunity to share concerns on these establishments located in our neighborhood. Your comments should be provided, in writing two weeks prior to the petition date, to your Commissioner in your Single Member District. SMD 01....David SMD 02...Eric

- 8.1 Presentation by Councilmember Jack Evans...Councilmember Evans' provided an overview of the City's fiscal and budgetary positions. He shared four challenges facing the City: 1. School System Issues, 2. Public Safety, 3. Affordable Housing, 4. Job Creation. A resident asked about the Supercan replacement program which is included in the FY 2014 Budget. Jack suggested that residents should continue to support two day per week trash pickup regardless the size of trash cans being used.
- 8.2 Fire, Safety and Prevention...Chief Kenneth Ellerbe (DCFEMS)... Chief Ellerbe provided an overview of the Fire and Emergency Medical Services Department. He spoke of the EMS Resource Redeployment Plan, staffing plans and measures being taken to provide improved services. He addressed a number of questions regarding staffing and emergency equipment/personnel deployment.
