Chartash*, a student in Journalism & Mass Communications, The George Washington University with us this evening covering the meeting for a class and *Hector Huezo*, ANC 1C02 Commissioner.

- 5. Administrative/Financial Matters:
- 5.1 Commissioner's Comments...No comments to be made.

- 6.1 MPD (PSA 208)...Lieutenant Chanel Dickerson; Lieutenant Dickerson highlighted recent crime statistics which shows a slight increase in various crimes in the commercial/entertainment sections of PSA 208, 47% reduction in theft from autos, and reported that a suspect had been arrested in the Decatur Place robbery but 3 individuals remain at-large. She also reported on recent concerns raised over speeding traffic on Connecticut Ave and the installation of the promised speed camera on the Taft Bridge. Lt. Dickerson told of her work with DCRA and OAG in regards to 2220 Q.

- 6.3 Council Member's Office...Tom Lipinsky <u>tlipinsky@dccouncil.us</u>; Mr. Lipinsky provided an update on the vacant property at 2140 Wyoming Street; reviewed the snow/ice removal regulations which currently require all property owners to clear sidewalks into 24 hours after the inclement weather has

ended and infractions of this should be reported to 311 or Department of Public Works; and briefly mentioned that the Council was engaged in Budget Oversight hearings.

- 7.2 Task Force to Study Vacant, Abandoned and Neglected Properties in Sheridan-Kalorama; the Commission will take no further action for the Sheridan-Kalorama Neighborhood Council has established a task force to study the problem and will have a report to release in the next several months.

- 8.1 2220 Q Street NW; following a presentation of the concerns regarding the use of the property in a residential zone as a commercial event site, the Chair opened the floor for discussion. Commissioner Bender moved and the motion was seconded, "that the Commissioners of ANC 2D, meeting on February 23, 2015, endorse the request of a group of residents who have raised concern over the use of 2220 Q Street, NW, zoned as a residential property being rented out for commercial purposes as an event site. The ANC further supports that this concern be raised with all agencies/departments within the District of Columbia Government which have jurisdiction over the health, safety and welfare of the public; such as Alcoholic Beverage Regulation Administration, zoning, licensing, permitting, police and public safety, Office of the Attorney General, public works and transportation". **Approved**
- 8.2 Spanish Steps Wedding Request (September 13, 2015; 3-6PM); (Lightfoot) Commissioner Bender moved and it was seconded "that ANC 2D approve the request for a permit to be issued by the DC Department of Parks and Recreation to hold a wedding at the Spanish Steps on September 13, 2015; 3-6 PM as submitted by Michael Lightfoot. Provided that he ensures, that at the conclusion of the ceremony, the STEPS, fountain and park are free of clutter/debris". **Approved**
