### **Meeting Minutes**

- 1. The Meeting was called to order at 7:03 PM.
- 2. A quorum was established: Present 2 Commissioners and 35 Residents/Guests.
- 3. Agenda was **approved** as published.
- 4. The Minutes of the May 21, 2012, Meeting were **approved** as published and distributed.
- 5. Administrative/Financial Matters
  - 5.1 Treasurer's Report...
  - 5.1.1 The current fund balance is \$3754.00.
- 5.1.2 Commissioner Lamar summarized the applications received from the Community Not-for-Profit organizations and recommended that the following organizations be awarded 2012 Grants: 1. Views; 2. Friends of Mitchell Park; 3. Restore Mass. Ave.; 4. S-K Call Boxes; 5. Spanish Steps; 6. Language Etc.; 7. SKHA; and 8. Textile Museum. Each grant will be for \$450.00; totaling \$3,600.00. Motion was seconded and **approved** (The Grant program was established on January 23, 2012, with the approval of the ANC 2D 2012 Budget)

- 7.4 Call Boxes...Phil Baker...The Call Box on Belmont Road has received repeated vandalism which has been reported to MPD. Four more boxes have been refurbished.
- 7.5 Language ETC...Phil Baker...The program has had over 700 students enrolled this year. He announced that he had resigned from the Board directors.

- 7.8 Spanish Steps...David Bender....Jackie Stanley, Consumer Outreach Coordinator, Department of General Services, announced that Kadcon Construction had been awarded the contract to do the restoration work. Work will begin on July 7<sup>th</sup> lasting approximately 10 to 12 weeks. Throughout this time access to the STEPS will be limited. The scope of the work is to refresh the area, upgrade the drainage system, regrade the land surface, plant new landscaping and ensure the working condition of the fountain.

### 8. Old Business:

8.1 Update on Chinese Embassy Project....Remediation of 2310 (the old building) has been completed and 2300 is about a third done. Completion date for all remediation work is early July. At this time the facade supports will be erected and the demo will commence shortly thereafter.

#### 9. New Business:

- 9.1 Department of General Services...Jackie Stanley....Consumer Outreach Coordinator, Department of General Services provided an overview of the mission of the newly created Department. The Department is responsible for making repairs and replacement equipment in parks, schools, recreation centers and fire stations. This agency is now responsible for the maintenance of both Mitchell Park and The Spanish Steps.
- 9.2 2130 Bancroft....Adjustment for Variance Relief (Goulston and Storrs.....Following an overview provided by Allison Prince, Attorney, and James Mark, Architect, comments were made regarding the merits of the project. In Prince's introductory remarks she stated that they were not seeking action at this ANC meeting but were rather wanting to hear comments. Five neighbors and a representative from the SKHA expressed a series of concerns ranging from quality of life issues to legal issues. No positive comments were made.
- 9.3 1901 24<sup>th</sup> Street....Christian Zapatka...Following an overview of the project [to install a parapet around the roof top air conditioning condenser units], comments were received from the owner of the adjacent property at 2337 California Street and SKHA (who opposes the project), a motion was moved by Commissioner Bender and it was seconded that the ANC support the installation of a 3 sided parapet (leaving the back side along the adjacent property open) which enables light and air to past through the to-be-erected surround.

DDOT is seeking the public's cooperation in using a new **Property Damage Only Crash Form** to enable the agency to better identify crash locations. The form should be used only in non-injury fender-bender incidents where minor crashes occur and are not typically reported by the MPD. Residents can obtain the Property Damage Only

Crash Form from an MPD officer and DDOT urges drivers to keep the forms in their vehicle's glove compartment. The form will be available online on the DDOT and MPD websites.

On Tuesday, May 29, 2012, The Mayor's Advisory Neighborhood Commission Chair's Roundtable met. The program began with an overview of the FY2013 Budget and a discussion of its approval process. Deputy Mayor Victor Hoskins provided an overview of the recent ICSC Global Retail Real Estate Convention which City Officials attended in Las Vegas.
